Tim Rainey

Tim spoke on the role of the State Workforce Development Board and the Board's vision in work. The CWDB's board role is to put forth the broad vison of the Governor and the Labor Secretary. We work to develop a strategic workforce plan that reflects the Governor's vision for the system over the next ten years. We update the plan as we progress through the years to keep it up to date. We organize the state organizations and departments administer the broader workforce system. We run the demonstration projects, we put out grants as a way to reflect and build what we are trying to achieve with our policies and our convening work we do.

Our most important function is to support the local WDBs across the state. We help shape the strategic plan and use our dollars help them get to accomplish their local vision. He asked our group to provide feedback on how they are doing. Our charge is to imagine what the workforce system can be, not take it from what currently is now. We are not the boss, but we have high expectations for the system.

WIOA funds are what we use to put forward and accomplish many of our ideas that we rely on local boards to create, execute and accomplish. WIOA is a \$400 million bucket of funds we spread out over the state. Part of our primary role is to put forth a compelling vision and selling it. Identify where the need is and where the funds can have the greatest impact by bringing together local and regional leadership to focus on common goal.

The CWDB on behalf of the Governor has put forth a vision called "High Road" which focuses on regional demand and supply. Demand meaning, working with employers in the industry sectors driving regional employment for current and future needs. Tim explained the "High Road" concept, (technical problems occurred throughout the presentation).

Angelov explained High Road Statewide grants statewide grants will be unveiled and the largest grant will be provided to the Inland Empire. The leading applicant is the Inland Empire Labor Institute, lead by WDB member Ricardo Cisneros. The \$1.3million grant is a seed grant to open up funds from other areas. The partners in this effort are: Inland Empire Labor Institute, The International Brotherhood of Teamsters, and the Warehouse Workers Resource Center. These entities are a resource to thousands of essential workers throughout our region. The grant will develop a training center that will provide a broader vision of economic development and bolster up apprenticeship and job training opportunities.


WORKFORCE DEVELOPMENT CENTER CAREER SERVICES REPORT December 2020






Participants Receiving Career Services - December 2020



EMPLOYER SERVICES REPORT

December 2020

The Employer Services teams at each of the Riverside County Workforce Development Centers/America's Job Centers of California in the cities of Hemet, Indio, and Riverside provide free services, programs, and business consultation to local employers. Services include applicant recruitment assistance, resume screening, job fair development, international trade support, tax credit information, on-the-job training reimbursement, small business development referrals, strategic partnerships, and assistance to improve business development processes.

There has been a significant increase of Workforce Services requested by businesses in Riverside County.


- Many WARN letters* have been submitted from businesses furloughing employees.

*WARN letters are provided to local officials and agencies by employers undergoing layoffs or closures pursuant to the Worker Adjustment Act and Retraining Notification (WARN) Act. Upon receiving a WARN letter, the Workforce Development Center offers informational presentations to affected businesses and workers.

Business Engagement & Outreach

Anytime a business consultant has an in-depth conversation, one on one, with an employer where the discussion is based around the needs of the business and a thorough description of services Workforce Development can provide. In December 2020, we connected with 64 businesses, 26 of them new, 38 of them repeat.




When a business reports that it has filled a job opening. One challenge is sometimes the opening takes longer to fill than the reporting period shows, or the business does not report it has filled the position.



The Business Solutions team has actively engaged with every employer that has submitted a WARN notice to ensure that their employees are connected to our services.


