Subject: Workforce Investment Act (WIA) Program Year 2007-08 Funding Recommendations for the operation of the Youth Opportunity Centers of Riverside County.

Motion: That the Riverside County Workforce Development Board (WDB) Executive Committee recommends for approval to the Riverside County Board of Supervisors the PY 2007/08 Youth Opportunity Center funding recommendations within 10% of the recommended amounts (attached).

Background: The Riverside County WIA Youth System is designed to provide long-term comprehensive services which support the education and employment success of all youth. Operated by community partnerships, the Youth Opportunity Centers of Riverside County serve as "one-stop" centers where youth can receive the support and services they need. Each partnership offers youth a variety of developmental activities that support academic achievement and workforce preparation.

In February, 2007, a Request for Proposal (RFP) was released to solicit Lead Agencies to operate existing Youth Opportunity Centers. The procurement covers a period of three years, effective July 1, 2007 through June 30, 2010 Partnership contracts will be awarded to Lead Agencies on an annual basis with continued funding being based on the partnership providing satisfactory service delivery, meeting quality standards, achieving program performance goals and availability of WIA youth funding.

WIA allocations have been decreasing steadily over the past five years. Therefore, in determining appropriate funding allocations, staff not only had to consider the evaluation score of the proposals, but also the needs of the communities throughout Riverside County. The recommended funding serves those communities with the greatest need and the least amount of resources. Due to the limited funds, and after much consideration, six Youth Opportunity Centers are recommended for funding.

This item will have been presented to the Riverside County Council for Youth Development (CYD) Operations for their recommendation on the morning of May 16, 2007.
